### Quarter in Focus

IPS organized and co-organized a range of dialogues, discussions and deliberations during the quarter, gathering valuable insights and providing policy inputs and recommendations on a variety of critical national and international issues.

The highlight of the quarter was the international seminar on the role of religions in fostering peace, harmony, and justice, which brought together scholars and intellectuals from six different faiths on one platform in a bid to explore religion's role in promoting global peace and harmony. Prior to this, an insightful session on reshaping cultural connections in the globalized world was held as a precursor to the international seminar.

Several activities were conducted under the theme of Pakistan Affairs, including comprehensive discussions on the 26th amendment to the constitution, national unity and ethnic pluralism, poverty alleviation, food security, and genetically modified organisms (GMOs) in Pakistan.

The country's energy concerns also received due attention, with deliberations addressing current challenges and opportunities for the future, focusing on energy priorities, the solar surge, and issues in the contracts of Independent Power Producers (IPPs).

A lecture series titled 'Pakistan: A Natural Geopolitical State' was organized with Owais Ahmed Ghani, former governor of Knyber Pakhtunkhwa and Balochistan, with two sessions being held at the Quaid-i-Azam University and Bahria University in Islamabad.

A discussion with Ambassador (r) Afrasiab Hashmi deliberated on the diplomatic and strategic realities of Pak-India relations, while a separate session analyzed Israel's atrocities in Palestine and the role and response of the international community.

IPS organized three book launches during the quarter, in addition to collaborating with the Quaid-i-Azam University's School of Economics to produce the 2<sup>nd</sup> International Islamic Economics Conference.

The Institute's Chairman spoke at China's Sanya Public Security Forum, urging reforms in global governance, apart from presenting IPS's study 'Politics and Governance in Pakistan' at the Islamabad Policy Research Institute. The Vice Chairman also spoke on cultural diversity and unity in a dialogue organized by the Institute of Regional Studies (IRS), Islamabad. Furthermore, IPS signed an MoU with the Institute of Strategic Studies Islamabad (ISSI) to collaborate in the areas of mutual interest.

Under IPS LEAD, the Institute hosted a delegation of students from Jamiat Al-Kauthar and organized a creative writing workshop for aspiring students and young professionals. A session of IPS' oral history project, 'The Living Scripts,' was also held with Iftikhar Gilani, a renowned Kashmiri journalist.

On the research side, the IPS' study Landscaping IPPs across Pakistan' garnered appreciation from various quarters, while its briefs on the trajectory of Pak-Afghan relations and the Mubarak Sani case were also well received.

At the publication's front, two book titles—Geopolitics: Frameworks and Dynamics in a Multipolar World and Dominance on the Digital Battlefield—were published by IPS Press during the period.



### 'The Role of Religions in Fostering Peace, Harmony, and Justice'

There is an inseparable link between the role of religions and peace and development, as no society can flourish without the foundations of harmony, justice, and mutual respect. This connection has global significance, with particular relevancy for Pakistan, as collective efforts are essential to bridge divides, foster inclusivity, and pave the way for sustainable development and equitable growth.

These views were shared by Ahsan Iqbal, federal minister for Planning, Development, and Special Initiatives, while speaking

as chief guest at the inaugural session of an international seminar, 'The Role of Religions in Fostering Peace, Harmony, and Justice', held at IPS on December 4, 2024, in collaboration with Allama Iqbal Open University (AIOU), National University of Modern Languages (NUML), Islamabad, University of Management & Technology (UMT), Lahore, Gift University, Gujranwala, The Islamic Foundation (IF), UK, and Markfield Institute of Higher Education, UK.

## 'The 26th Amendment of the Constitution of Pakistan: Significance and Impact'



The 26th Amendment to the Constitution of Pakistan has the potential to address longstanding challenges, provided that transparency, inclusivity, and institutional harmony are prioritized. While debate is inevitable in constitutional developments, and there is a critical balance between judicial

independence and parliamentary oversight, it is essential that the amendment be critically

evaluated to ensure the development of law, constitutional principles, and effective justice delivery.

Legal practitioners and scholars noted this during a roundtable titled 'The 26th Amendment of the Constitution of Pakistan: Significance and Impact' held at IPS on November 27, 2024.

The session, chaired by Ahmer Bilal Soofi, advocate Supreme Court of Pakistan, was addressed by Khalid Rahman, chairman IPS, Jam Muhammad Aslam, Ministry of Law and Justice, Syed Ahmad Hassan Shah, advocate Supreme Court of Pakistan, Hafiz Ahmed Waqas, Shariah Academy, International Islamic University, Islamabad, and Dr Shahzad Iqbal Sham, senior

## 'Israeli Aggression: Perspectives, Policies, and Emerging Scenario'

Israel, driven by messianic ideological motives, has become *hostis humani generis*, an "enemy of mankind," as it continues to impose collective punishment and apartheid in the Palestinian territories. The reality of these actions has emerged, despite the widespread disinformation in the Western media, leading to overwhelming international support for Palestinian resistance. In this context, supporting Israel or maintaining neutrality is equivalent to complicity in these crimes.

This was observed during a seminar on 'Israeli Aggression: Perspectives, Policies, and Emerging Scenario' held at IPS on October 18, 2024. The session featured distinguished

Presenting an overview of the 26<sup>th</sup> Amendment, Jam Aslam emphasized that due deliberations preceded the passing of the 26th Amendment to introduce changes in the legislative scheme. Key provisions included the establishment of special constitutional benefices in the Supreme Court and kink pourte and benches in the Supreme Court and high courts and restructuring of the chief justice's appointment process. Furthermore, the amendment introduced performance evaluations for high court judges, reduced the age limit for high court judges' appointments, and allowed Federal Shariat Court judges to ascend to the Supreme Court ascend to the Supreme Court.

### 'Pakistan-India Interaction: Ancient and Contemporary

Perspective'

The enduring and distinct cultural identities and traditions of Pakistan and India continue to shape their political realities even decades after partition. These historical identities remain influential in their diplomatic discourse and strategic interests in South Asia.

This was discussed by Ambassador (r) Afrasiab Mehdi Hashmi Qureshi, who has also served as additional foreign secretary, during his guest lecture on 'Pakistan-India Interaction: Ancient and Contemporary Perspective', held at IPS on October 9, 2024. The event drew a diverse audience, including students from various universities, who gathered to gain deeper insights into Pakistan and India's complex history and evolving dynamics.

Ambassador Afrasiab, who has served as Pakistan's high commissioner to Bangladesh and New Zealand and held key diplomatic positions in Washington DC, New Delhi, Beijing, and Vienna, emphasized that the roots

of Pakistan-India interaction extend far beyond the partition of 1947, going back thousands of years. He pointed out that while the regions of present-day Pakistan and India have been geographically interconnected, they have always maintained distinct cultural, religious, and philosophical identities. These differences have not diminished with the establishment of political boundaries and continue to impact the relationship, which is often characterized by tension and cautious cooperation.

### 'Food Security and Genetically Modified Organisms (GMOs) in Pakistan'

With scientific findings on GM crop safety still inconclusive, a strategic evaluation before introducing GMOs in Pakistan is essential and should be guided by a robust regulatory system. This mechanism, grounded in indigenous research, mobilization of local

resources, and tailored safety standards, must account for Pakistan's unique agricultural and environmental conditions. Moreover, addressing ethical, health, and environmental concerns is equally paramount. As Pakistan explores this path, a framework that prioritizes national interests, public health, and ecological balance remains crucial

This was discussed during a roundtable on 'Food Security and Genetically Modified Organisms (GMOs) in Pakistan' held at IPS on October 29, 2024. The panel included Khalid Rahman, chairman IPS, Dr Anwar ul Hassan Gilani, former vice-chancellor, The University of Haripur, Dr Shaukat Ali, director National Institute of Shaukat Ali, director National Institute of Genomics and Advanced Biotechnology (NIGAB), and Dr Zahid Akram, professor, PMAS Arid Agriculture University, Rawalpindi. The session was also attended by academia, experts, government officials, researchers, and representatives of formers. tatives of farmers.

The discussion noted that while genetic



modification has become integral to advancing agricultural technology, there remain valid concerns over its long-term impacts on human health and environmental stability. This highlights the need for a strategic evaluation and robust regulatory framework, that is efficient in both content and implementation and prioritizes long-term gains of food security, public health, and environmental sustainability.

The speakers noted that research, highlighting the potential of GM crops to meet the demands of a growing population by focusing on their high-yield capacities and resilience to pests, weeds, and adverse weather conditions, is mostly donor-initiated. However, these donor initiatives may overlook local agricultural realities and the priorities of primary stakeholders, such as farmers and consumers.

## 'Pakistan is a Natural Geopolitical State' – Owais Ahmed Ghani's Lecture Series



Owais Ahmed Ghani, former governor of Khyber Pakhtunkhwa and Balochistan, and member of the IPS' National Advisory Council (NAC), delivered lectures on 'Pakistan: A Natural Geopolitical State', held at School of Social Sciences and Humanities, Bahria University, Islamabad Campus (BUIC), and National Institute of Pakistan Studies, Quaid-i-Azam University (NIPS-QAU), Islamabad, in collaboration with IPS, on October 17 and 30, 2024 respectively.

The lecture at Bahria University was joined by Ambassador (r) Syed Abrar Hussain, vice chairman IPS, Dr Shoaib Suddle, director and senior fellow, Global Think Tank Network, National University of Science and Technology (NUST), and Syeda Sughra Imam, former senator, whereas the lecture at the Quaid-i-Azam University was joined by Khalid

Rahman, chairman IPS, Dr Muhammad Hanif Khalil, associate professor and acting director NIPS, and Dr Saeed Amed Rid, assistant professor, NIPS.

In his lectures, Owais Ghani presented a comprehensive historical analysis that positioned Pakistan, centered in the Indus River region, as a distinct political entity throughout history. He highlighted that the region's unique geopolitical and cultural identity has consistently set it apart from the rest of the subcontinent. Drawing on 2,600 years of history, Ghani demonstrated that for the majority of this period, the Indus River region has functioned independently of the Ganga-Jumna region, with a distinct social, cultural, and political character.

## 'Poverty Alleviation in Pakistan: Examining the Concept and Performance of BISP'



Pakistan must adopt a strategic shift in social protection policies to tackle poverty and unemployment, with a sustained and responsive 8% economic growth rate over 8-10 years identified as essential to generating sufficient job opportunities.

Achieving this requires a growth-oriented, inclusive, and data-driven approach, along-side comprehensive structural reforms. Key measures include decentralizing program management and prioritizing human capital development to transform social safety efforts into sustainable economic progress.

This was discussed during an interactive session on 'Poverty Alleviation in Pakistan: Examining the Concept and Performance of BISP' held at IPS on October 22, 2024. The event, chaired by Dr Ghulam Muhammad Arif, former dean, Pakistan Institute of Development Economics (PIDE), featured insights

from Dr Shujaat Farooq, chief of research, PIDE, Khalid Rahman, chairman, IPS, and other experts.

The session critically examined the current state of poverty alleviation efforts in Pakistan, with a focus on the Benazir Income Support Programme (BISP), its effectiveness, and the broader structural challenges facing the country's social protection programs.

Dr Shujaat Farooq explained that BISP, despite being a significant social safety net, has become heavily donor-driven, with conditions from international organizations like the IMF. This has made it challenging for the government to modify or discontinue the program, despite its limitations, as it has not had a positive impact on poverty alleviation even after 16 years.

(\$EZs), can lead to more equitable and efficient outcomes for both producers and consumers.

To achieve targeted solutions, a more transparent and tailored approach is essential. A case-by-case evaluation of IPPs is crucial, as each operates under distinct financial and operational conditions.

This was discussed during a consultative meeting on 'Unpacking the Issues in IPP Contracts: Insight from Experience and Emerging Scenarios', held at IPS on October 8, 2024. The insights were shared by Naveed Siddique, a consultanting Engineer with diversified experience in various subsector of power sector of Pakistan. including Ministry, regulatory authority, vertically integrated utility, and IPPs, Khalid Rahman, chairman IPS, Mirza Hamid Hassan, former federal secretary, Water and Power, and Asad Mahmood, a renewable energy expert.

Earlier, IPS Research Officer Muhammad Wali Farooqi presented a comprehensive study on mapping Pakistan's IPPs, supported by detailed infographics.

### 'Ikkeeswi Sadi ka Bharat aur Musalman: Siyasat aur Samaaj kay Aeenay Mai'

A deeper and more systematic understanding of India's sociopolitical and cultural landscape, "Hindustan Sanashi", is a prerequisite for shaping effective policies for minorities, as well as advocacy efforts for marginalized communities like Muslims in India and Indian Occupied Kashmir.

### Chairman IPS at 2024 Sanya Forum | Global Governance **Reforms for International** Security and Sustainable **Development urged**

Chairman IPS Khalid Rahman was invited to speak at the 2024 Sanya Public Security Forum, held by China Golden Eagle Peace Development Foundation in Sanya, Hainan, China on December 21, 2024, under the theme of 'Development and International Security'.



Speaking online on the occasion, Rahman emphasized the vital, inevitable, and symbiotic relationship between security and development, stressing that the traditional approach of focusing primarily on military strategies is no longer effective in the modern world. He argued that for sustainable development, new and innovative ways must be identified to prevent conflicts, ensure safety, and build lasting peace. A secure environment fosters investment, innovation, and growth, while instability hampers economic, educational, and social progress, he said.

The speaker also highlighted the need for security measures at both local and global levels, addressing internal stability in China, regional security concerns like the South China Sea, and the growing risks associated with global initiatives such as the Belt and Road Initiative (BRI)

Speaking of BRI, Rahman said that the project highlights the importance of a community with a shared future for mankind, pays more attention to the sustainability of public security, and the principles of inclusiveness and joint consultation and construction. At the same time, the initiative integrates multiple dimensions of global governance such as economy, society, ecology, and security, and promotes the construction of a new governance model.

He concluded by advocating for comprehensive reforms in global governance to better address emerging security threats, as well as to ensure sustainable development in an increasingly interconnected world.


